2. Address Your MP Formally

Start your letter with a respectful greeting such as "Dear [MP's Name],".

3. Be Clear and Concise

Clearly state the purpose of your letter at the beginning. Explain that you are writing to advocate for the #CatsMatter campaign and the necessity of legislation requiring drivers to report incidents involving cats.
